THE SEARCH COMMITTEE OF THE BOARD DEVELOPED THE CRITERIA VIA PHONE CONVERSATIONS AND EMAIL IN PARTNERSHIP WITH THE INDEPENDENT SEARCH FIRM. THIS PROPOSAL WAS PRESENTED TO THE EXECUTIVE BOARD ON A WEEKLY CALL AND SENT IN WRITING TO THE FULL BOARD FOR DISCUSSION AT A BOARD MEETING. THE CEO'S FIRST PERFORMANCE REVIEW WAS PRESENTED TO THE FULL BOARD DURING THE OCTOBER 2020 BOARD MEETING. BASED ON THE POSITIVE EVALUATION, THE FULL BOARD VOTED TO INCREASE THE CEO'S SALARY BY 5%.

IN ADDITION TO THE CEO'S SALARY, THE BOARD APPROVES THE ANNUAL BUDGET, WHICH INCLUDES THE SALARIES OF ALL EMPLOYEES.
